issues. The relevance of cognitive  
techniques is also stressed. Basic training  
includes: Issues in Couples Therapy,  
Supervision of Couples Therapy, Short  
and Long Term Couples Therapy, and  
Readings in Theory and Practice of  
Couples Therapy: Advanced Training  
beyond the one and two year certificates  
is also available.*
